## Directions to the Show Site

**From Minnesota:** From either north or south take the Highway 2 (Bong Memorial Bridge) exit 253A and head east into Superior, Wisconsin. Go through the roundabout to Tower Avenue (2nd set of lights) and take a right onto Tower. Head south past Walmart and Menards and get into left lane by this point. Take a left at 46th on the north end of the fairgrounds and go to the first open entrance on the right into the fairgrounds.

**From Wisconsin (coming up Wisconsin 53 or across Highway 2):** Highway 53 merges with Highway 2 about 11 miles south/east of Superior. Continue into Superior heading north. After the lights at 18th street get into the left lane and continue north until you reach Belknap Street/Highway 2 (Bong Museum and Barkers Island will be on your right). Turn left on Belknap and stay in the left lane. Continue heading east until you get to Tower Avenue. Take a left onto Tower Avenue and stay in the left lane. Head south past Walmart and Menards until you reach 46th Street (north end of the fairgrounds) and take a left onto 46th and go to the first open entrance and turn right into the fairgrounds.

**From Wisconsin (coming up Wisconsin 35):**

As you enter the city you will pass through the Village of Superior on 35 first. Then after an opening you will see the fairgrounds on your right. 35 is the same as Tower Avenue here. Turn right on 46th street on the north end of the fairgrounds and go to the first open entrance and turn right into the fairgrounds.

*There will be Puppy, Bred By Exhibitor, & Open Classes for each of the Miscellaneous Breeds in each sex.  
Puppy and Bred-By classes will be divided by age if all-breed classes are divided.*

Winners from these classes will compete for Best of Breed & Best of Opposite Sex to Best of Breed in each breed. Each Miscellaneous Best of Breed winner shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class. Ribbons shall conform to Chapter 5, Section 2 of AKC Rules.

## **JUNIOR SHOWMANSHIP COMPETITION**

**Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs**

**Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs**

**Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class**

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

## 4-6 Month Beginner Puppy Competition (Each Day)

### Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

### Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed, or member dog shows or conformation B- matches at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as “Exhibition Only” in the Four-to-Six Month (Beginner Puppy) Competition. “Exhibition Only” entries are not eligible to earn awards in this competition.

- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries.

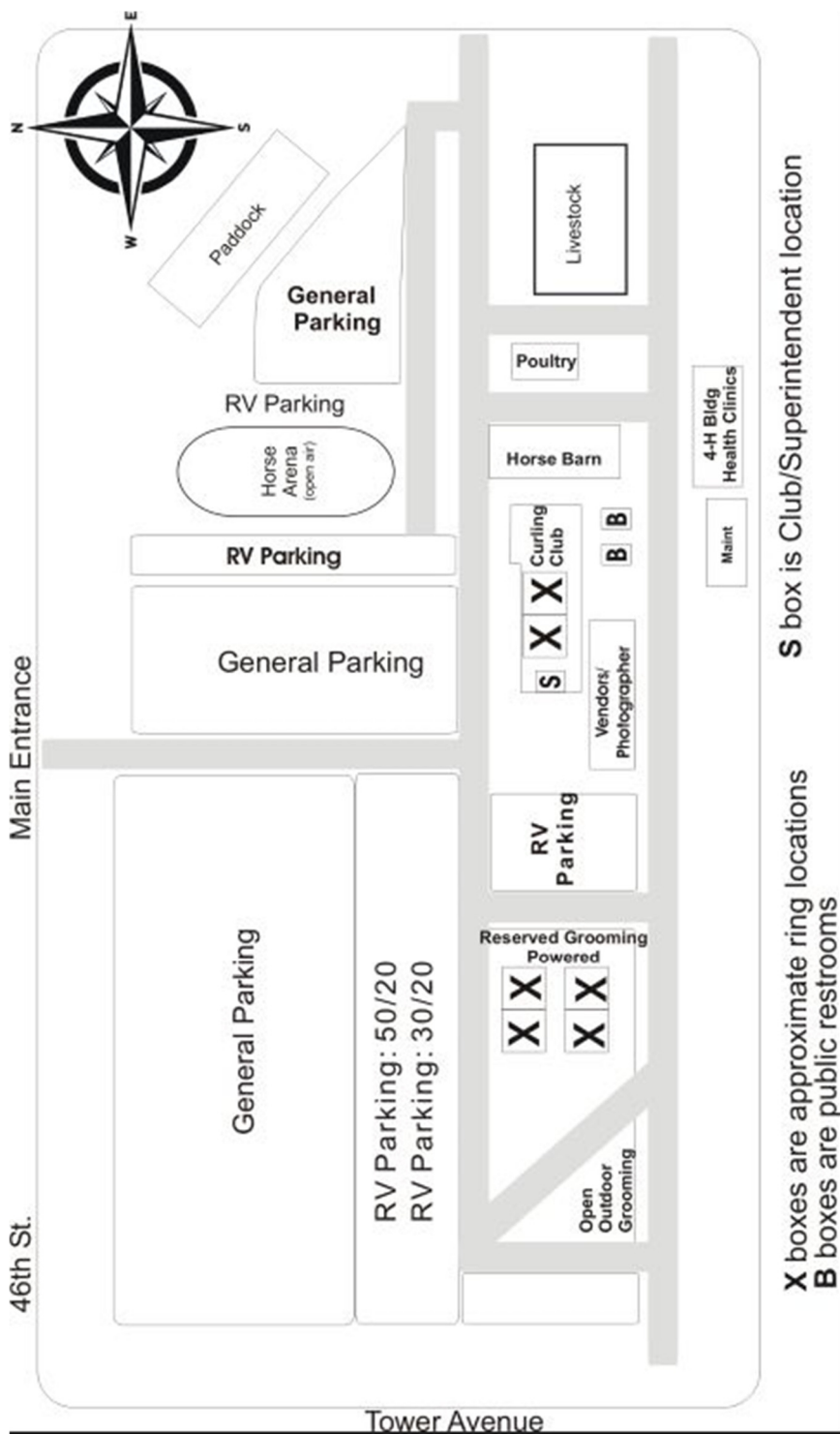

## General Information

- The show site will be open to RV's as early as Monday September 16<sup>th</sup> at 10am. RV Parking is reserved ahead of time this year. Please see the RV/ Parking page for more info.
- RV's on the asphalt side of the rings are not permitted to leave during show hours per AKC show site rules.
- Reserved grooming in the curling club and reserved grooming outdoors will open no earlier than 3pm, Wednesday Sept 20<sup>th</sup> for load in, unless otherwise stated by the show staff.
- There is no parking on the access road in front of the outdoor open grooming area. You may unload from the access road Wednesday, and each day prior to the start of the show, but you must park on the outside of the fence line during show hours. There is also no parking on the gravel access road next to reserved outdoor grooming. This is for unloading and loading only before and after show hours. This road will be closed to traffic during show hours per AKC dog show regulations.
- The curling club will open at 6am each morning and is locked at 10pm each night. No night security will be onsite. Dogs may be left in the building overnight. HOLKC and LMKC are not responsible for any dogs and equipment left overnight.
- Outdoor free grooming area is on grass. Bring your own pop up tents. Please stake your tents. Generators may be used but must be at least 50ft from any ring or building. Please feel free to groom at your vehicle in the general parking area. If using pop ups, please plan to bring weights. The parking lot is dense gravel. Pop ups may be left set up in general parking but this is at your own risk, and it can be windy at this site.
- Open indoor grooming is located in the horse barn and poultry building. Horse barn has dirt floor stalls and very limited power. The poultry building has a cement floor and there is power available.
- No generators may be used within 50 feet of any ring or in any building.
- This is a self cleaning show. Please pick up after your dogs. There will be multiple receptacles to place pet waste in.
- General Parking is \$5 per vehicle per day. A weekend pass for all 4 show days can be purchased for \$20. There is no charge for parking on setup day (Wednesday).

# AKC Code of Sportsmanship

**PREFACE:** The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

**No Refund for Duplicate Entries.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor the Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging.

Judges need not wait for any dog holding up the class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

**The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.**

**PUBLICATION RIGHTS** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
